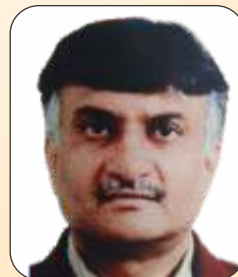

Hon. Secretary Shri Nitin Mehta informed that minutes of 26th minutes has been given on page 4&5 and sent to members by Email. He requested members to pass the same. As no modification was offered by members it was passed unanimously.

Agenda: 2**To receive, consider and approve the report of the Administrative Committee for the year 2020-2021 about the Administration and Activities of the Scheme.**

Hon. Secretary Shri Nitin Mehta informed that Administrative committees report has been published on page 9 to 11 in the annual report.

- We are having 3823 Active members
- 41 members expired during last year due to Covid-19
- We enrolled new 15 members during this year

1865 members have opted for ECS and 1452 have opted for deposits. We are requesting them to join by deposit also.

- Last year our deposit was Rs. 10.21 crores which this year is Rs. 10.12 crores. This reduction is due to utilising FDs for paying FC to 41 deceased members due to Covid-19.
- Last year we could do only 1 physical programme and 6 Webinar programmes. We did one programme on mammography and one health check-up programme. Some members enquired as to why our deposit has been reduced. He informed that due to pandemic 41 deaths we had to encash Fd's to pay FC to deceased member's families. He requested members to pass the agenda. Members passed the same unanimously.

**Agenda:3****To receive and consider Audited Accounts of the Scheme for the year 2020-2012.**

Hon. Secretary Shri Nitin Mehta requested Hon. Treasurer Shri Minesh Shah to present audited accounts for year 2020-2021.

- Hon Treasurer Shri Minesh Shah informed that Audited accounts are published on page 14 to 26.
- He informed that against projected income of Rs.79 lakhs actual income was Rs.80.89 lakhs and against projected expense of Rs.12.55 lakhs actual expense was Rs.8.30 lakhs. Members passed the audited accounts unanimously.

He also informed that for healthcare activities we have made provision of Rs.2.25 lakhs.

Amendment of contribution member's Fraternity Contribution – Chapter – VII – 1

Constitution (B) rules and regulation clause VII – 2.

Dr. Vatsal Patel informed that we need to make change in constitution about fraternity contribution and corpus fund of Rs.100+Rs.30 as interest rates are declining and if we have to sustain we should increase the same.

- He proposed to increase corpus fund/Adm.charges toRs.50 from existing Rs.30.There was lot of debate and suggestions from the members but ultimately it was decided to raise it to Rs.50.
- Shri Navnit Thakershy suggested to increase Annual Maintenance amount from existing Rs.90. After lot of discussion it was decided to increase it to Rs. 150. All members agreed to above both amount amendments.

**Agenda:8****Any other business with the permission of the Chairman.**

- With the permission of chair Shri Navnit Thakershy suggested that we should make some system or machinery so that in case any member gets defaulted by not paying his contribution other willing member should take his burden and pay on his behalf.
- we should see that no one should get defaulted.
- we can have a benevolent fund to take care of his default amount.
- He also suggested to give back to scheme at least Rs.1 lakh out of FC amount of approx. Rs 3.75 lakh received.

Dr. Vatsal Patel gave example of some member who donated for gold medal out of their FC. Shri Chirag Patel

suggested that if a person defaults we should deduct our expenses but should refund balance occurred amount.

- Shri Hasmukh Mehta informed about why there is need for increasing membership. He suggested to admit children of Members in SSS to increase membership.
- Dr. Vatsal Patel suggested to call a broad based meeting to discuss required constitution changes and calling a special AGM. Shri Rakesh Parekh gave his views on membership.

We have audited the attached Balance Sheet of SOCIAL SECURITY SCHEME OF GICEA as at 31st March, 2022 and Income & Expenditure Account of the above named trust for the year ended on that date annexed thereto. These financial statements are the responsibility of the trustees. Our responsibility is to express an opinion of these financial statements based on our audit.

We conducted our audit in accordance with auditing standards generally accepted in India. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatements. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statement. Audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audit provides a reasonable basis for our opinion.

As required by section 34 of Gujarat Public Trust Act, 1950, we report as under:

1. The accounts are maintained regularly and in accordance with the provisions of the Gujarat Public Trust Act, 1950 and Rules;
2. Receipts and disbursement are properly and correctly shown in the accounts;
3. The cash balance and vouchers in the custody of the manager/accountant Shri Vaikunthbhai on the date of the audit are in agreement with the accounts;
4. Books, deeds, accounts, vouchers and other documents or records required by us were produced before us;

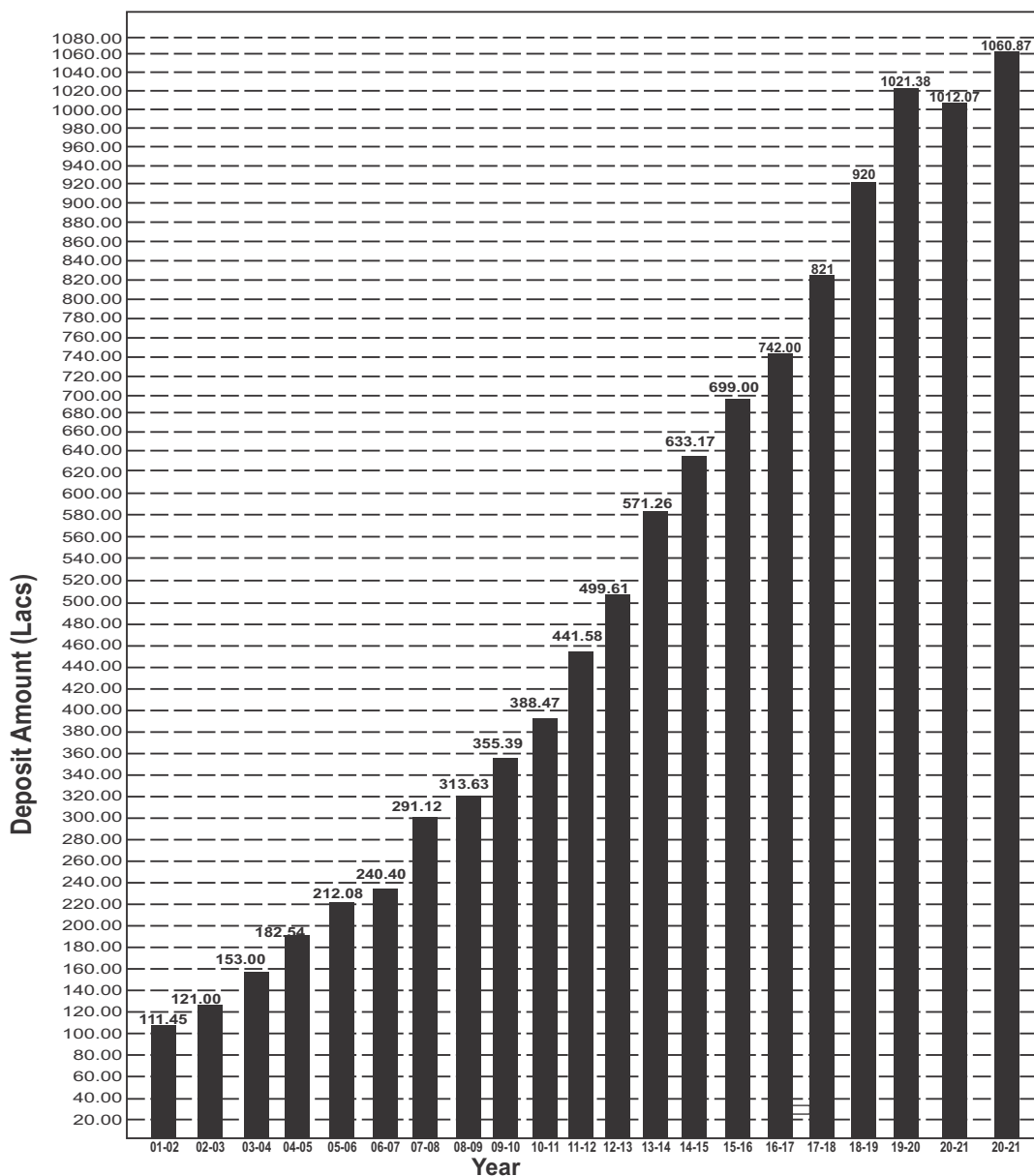

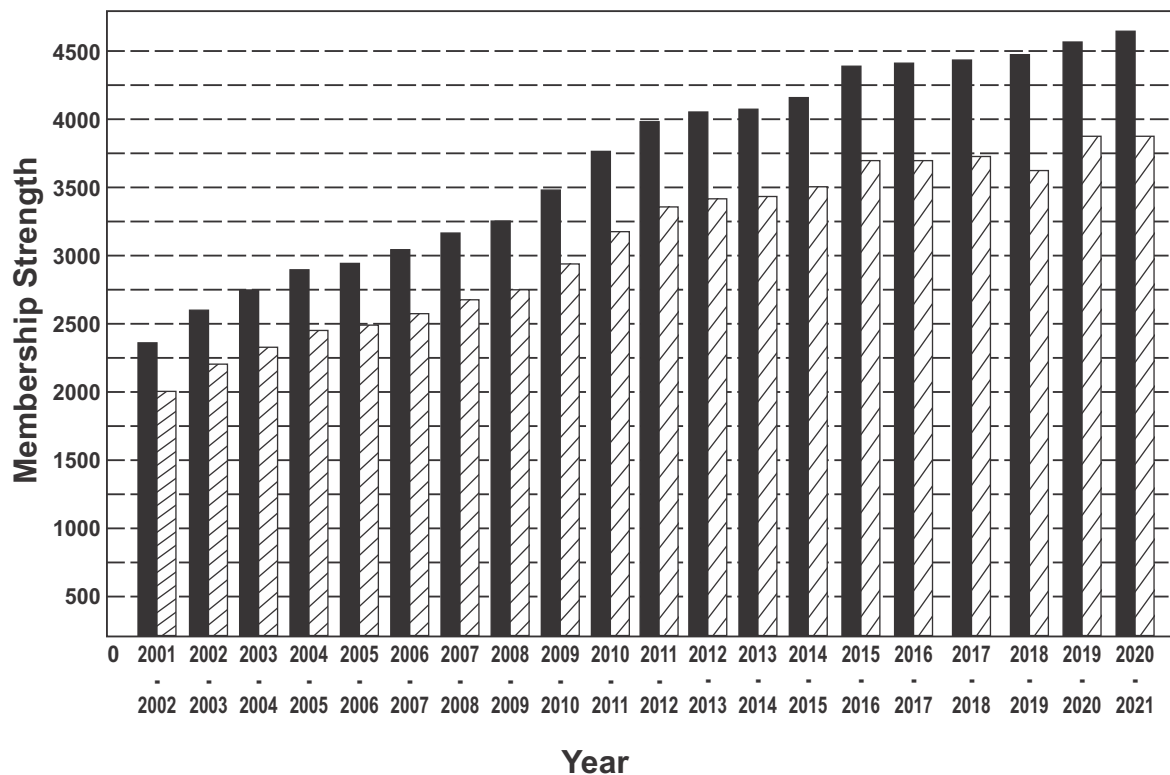
GRAPH SHOWING GROWTH OF DEPOSITS
