3. All the above seats are to be filled in from the members of the respective categories. Members willing to serve in the Managing Committee are invited to file candidature form latest by **19.02.2018 upto 6.00 p.m.**

Candidature form will be available from the office of the institute from **03-02-2018** on written request and on payment of Rs. 50/- which shall be adjusted against the deposit of Rs. 500/- which is required to be paid at the time of filing the form. In case the member decides not to file the candidature form this amount shall not be refunded.

4. (4.1) Member for the Managing Committee for different category as detailed below will be elected by the members attached to that category and shall vote for the candidates equal to the number of seats of the particular category.

(1) FLM Category - 15 Seats (2) Patron Category - 1 Seat

(2) ASLM Category - 1 Seat

(4.2) Retiring Members are eligible to contest again.

FLM members may please note that they have to give votes to 15 members in category(1), if the number of votes cast is more or less then 15, such ballot paper shall be considered invalid and it shall stand rejected. Similarly in ASLM & Patron Category Voters shall cast one vote only.

- (4.3) Candidate shall pay additional Rs. 450/- as deposit by Cash / Banker's Cheque/DD in the name of GICEA and obtain a receipt from the office and enclose a Xerox copy with their Candidature Form. A candidature form submitted without paying deposit shall be rejected.
- (4.4) If a candidate fails to secure votes equal to or less than 10% of the valid votes cast in his category, his/her deposit of Rs. 500/- shall stand forfeited. IN other cases when candidates is elected for secures higher percentage of votes or where candidature form is withdrawn or the election is not held Rs. 500/- will be refunded without interest on or after 10-04-2018.
- (4.5) The candidature of a member will be supported by the member of his / her category only. Number of supporters required will be as under:
(i) FLM Category - 5 (ii) Associates member - 3 (iii) Patron Member - 2
- (4.6) A member desirous of contesting should have joined the institute as member in respective category on or before **31st March 2015**, and he/she must have completed 25 years of Age on 31-03-2015 as provided under cause 8.2 (b).
- (4.7) A member can contest election in the category in which he is registered on the last day of filling election papers i.e. on **19-02-2018** otherwise his / her form shall be rejected.
- (4.8) A brief bio-data of the candidate should be enclosed with the candidature form.
5. Election papers i.e. candidature form and all the enclosures as required should be delivered by a candidate in a sealed envelope in person to the institute office duly superscribed as under and obtain a receipt.
