## **Advisory for Voters about voting & Election Canvassing for FLM Candidate for Election 2020 of GICEA.**

1. Candidate are free to canvass for votes of members in all just and fair means.
2. Candidate can utilize social media, posters, pamphlet as well as do personal canvassing. Due care should be taken to avoid inconvenience & harassment to members.
3. Use of loudspeakers or slogans creating noise pollution should not be allowed.
4. Non member supporters should be asked to stay outside premises of GICEA. Members of GICEA also would be allowed inside premises only for voting purpose.
5. Poster should not be stuck inside or outside wall of GICEA Premises.
6. Candidate himself with one supporter who should be GICEA FLM Member can be present during the election process like checking of name in the list/issue of ballot paper etc. Candidate and his/her supporter shall submit his/her details with passport size latest photograph by 18/3/2020 so that ID card can be issued by scrutineer. Those with such I Card shall only be allowed.
7. Canvassing inside GICEA premises will not be permitted.
8. Voting / Ballot Paper will have names alphabetically as per circular no. **GICEA/Election/2/2020** dated 12-03-2020.
9. Vote should be given by marking ✓ mark in the box against candidates name.
10. In the event of any dispute the decision of the Board of Scrutineers shall be final and binding.
